## CITY OF MILES REGULAR COUNCIL MEETING MARCH 2, 2022 @ 6:00 P.M.

Miles City Council met in regular session on March 2, 2022 @ 6:00 p.m. at Miles City Hall. ROLL CALL: PRESENT: M. Leamy, D. Chrest, R. Lawrence, N. Corlis. ABSENT: D. Ernst. Mayor Dane Johnson presided.

APPROVAL OF AGENDA – Council member N. Corlis made a motion to approve the agenda as presented, it was seconded by council member M. Leamy. Motion carried. Ayes 5, Nays 0.

CONSENT AGENDA – Council member M. Leamy made a motion to the consent agenda, including the minutes of the previous meeting, paid, unpaid bills, financial statements, water, sewer, and maintenance reports, council member D. Chrest seconded the motion. Motion carried. Ayes 5, Nays 0.

CITIZEN/PUBLIC COMMENTS – Ernie Schulz.

## PUBLIC HEARING: PROPOSED BUDGET FY2022-2023.

Mayor Johnson opened the public hearing at 6:05 p.m. to solicit comments for the FY2022/2023 Budget. The primary purpose of the public hearing is for citizens to voice their objections or concerns. Mayor Johnson closed the public hearing at 6:06 p.m. with no negative comments from citizens present and no objections on file.

Motion by R. Lawrence and seconded by D. Chrest to close the Public Hearing for the FY Budget 2022/2023 at 6:06 p.m. No citizens comments, verbal or written oppositions were presented. Motion carried by roll call: Lawrence aye, Chrest aye, Leamy aye and Corlis aye.

# PUBLIC HEARING: NOTICE OF PROPOSED ACTION TO INSTITUTE PROCEEDINGS TO ENTER INTO A LOAN & DISBURSEMENT AGREEMENT IN A PRINCIPAL AMOUNT NOT TO EXCEED \$2,262,000.00.

Mayor Johnson opened the public hearing at 6:07 p.m. to solicit comments for the proposed action to institute proceedings to enter into a Loan & Disbursement agreement in a principal amount not to exceed \$2,262,000.00. The primary purpose of the public hearing is for citizens to voice their objections or concerns. Mayor Johnson closed the public hearing at 6:08 p.m. with no negative comments from the citizens present and no objections on file.

Motion by N. Corlis and seconded by M. Leamy to close the Public Hearing for the proposed action to institute proceedings to enter into a Loan & Disbursement agreement in a principal amount not to exceed \$2,262,000.00 at 6;08 p.m. No citizens comments, verbal or written oppositions were presented. Motion carried by roll call: Corlis aye, Leamy aye, Chrest aye, and Lawrence aye.

MAYOR'S REPORT- Mayor Johnson reported the city is eligible for the Disadvantage Community Determination. As a results of this determination, the City qualifies for the lower interest and extends the term loan to 30 years.

MAINTENANCE REPORT – City Maintenance, Paul Maze informed the council the curb box valve on Ferry Road needed to be replaced as did the lead piping to the curb box. Paul stated there are a number of curb box that need to be dug up and replaced on Ferry Road. Also, Paul informed the council the fiber optic will be installed between the 2 wells in the next couple of weeks weather permitting.

#### **CLERK'S REPORT - None**

### NEW BUSINESS.

Ernie Schulz approached the council inquiring the city's intention whether they want to contribute funds to the thresher's celebration fireworks. Council member Leamy questioned if we were to contribute where would the funds come from. City Clerk, Brenda Tebbe indicated Economic Development fund. After a discussion on cost of what other towns spend on fireworks, council member M. Leamy made a motion to purchase up to \$1000.00 of fireworks for the Thresher Celebration, council member N. Corlis seconded the motion. Motion carried. Ayes 4, Nays 0.

Mayor Johnson suggested to the council to approve amount of funds for the playground equipment. This is will give the Miles Community Improvement Group to narrow down their equipment purchase. Council member N. Corlis informed the council they have \$40,000.00 raised currently and their goal is \$100,000.00. Mayor Johnson suggested contributing \$50,000.00 towards the project, council member M. Leamy questioned where the funds would come from. City Clerk, Brenda Tebbe stated economic development fund. These funds come from property taxes and can be used for these types of projects. After a discussion on lighting for the park, and rubber mating for the equipment. Council member M. Leamy made a motion to contribute \$75,000.00 to the Miles Community Improvement Group for playground equipment, council member D. Chrest seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to approve Res. 2022-12, A Resolution adopting the annual budget for the fiscal year ending June 30, 2023, it was seconded by council member N. Corlis. Motion carried. Ayes 4, Nays 0.

Council member N. Corlis made a motion to approve Res. 2022-13, A Resolution taking additional action on proposal to enter into a Sewer Revenue Loan and Disbursement Agreement, council member M. Leamy seconded the motion. Motion carried. Ayes 4, Nays 0.

Up for discussion is hiring summer help for 20 hours per week. Mayor and council discussed whether to hire 1 or 2 people and as well as hourly rate. Council suggested depending on their work experience background, hourly rate would be more. They all agreed 20 hours per week per person, and hourly rate would be start at \$14.00/per hour depending work experience. Council member M. Leamy made a motion to hire 2 people, 20 hours per week, wage would be determined later, council member N. Corlis seconded the motion. Motion carried. Ayes 4, Nays 0.

Mayor and council discussed the Spring Newsletter 2022. Mayor and Council suggested to add Thresher's festivities, Truck Parking Limited Ordinance, and no big dumpster to the newsletter. Council member D. Chrest suggested to add if anyone would want to donate to the Miles Park Project or to the Thresher's fireworks, they could call City Hall for details.

Mayor Johnson suggested to create a Covid-19 policy for the City of Miles and implement on how the employees will get paid. Policy states employees will need to use their comp time or sick time first, if they don't have that option it will go before city council on whether or not they will get paid. Council member M. Leamy made a motion to approve the Covid-19 policy for the City of Miles, council member D. Chrest second the motion. Motion carried. Ayes 4, Nays 0.

ICAP performed a Risk Control Visit on February 10, 2022 at City Hall. The recommendation was for the city to conduct motor vehicle record check annually for all city employees and new-hires. Council member M. Leamy asked if this was legal. Mayor Johnson informed him even though he's self-employed he has to conduct a vehicle record check and keep documentation with him at all times. Council member N. Corlis made a motion to approve the city to conduct a motor vehicle record check annually on all city employees, council member M. Leamy seconded the motion. Motion carried. Ayes 4, Nays 0.

ADJOURNMENT – With nothing further to discuss, Mayor Johnson asked for a motion to adjourn. Council member M. Leamy made that motion, seconded by council member N. Corlis. Meeting adjourned at 7:01 p.m. Motion carried. Ayes 4, Nays 0.
