Chief Deputy, Jim Kraker presented a proposal to the mayor and city council in regards to Jackson County Sheriff's office providing law enforcement services for the City of Miles for a dedicated amount of time per week/month/year. The City of Miles is currently a party in a contract with the City of Preston for police services. Chief Deputy, Jim Kraker explained the proposed rates but indicated if the city is interested in there service, it would be in the best interest of the City to seat down and discuss options that would meet the City of Miles budget for police protection.

The primary purpose of the public hearing is for citizens to voice their objections or concerns. The clerk reported there were no negative comments from citizens present and no objections on file.

Motion by council member N. Corlis and seconded by council member N. Abernathy to closed the public hearing at 6:22 p.m. for the Proposed Budget FY2023/2024. No citizens comments, verbal or written oppositions were presented. Motion carried by roll call: N. Corlis aye, N. Abernathy aye, R. Lawrence aye, M. Leamy aye, and D. Chrest aye.

Lawrence to solicit comments on the Status of Funded Activities – Wastewater Improvement Project. The primary purpose of the public hearing is for citizens to voice their objections or concerns. ECIA – Matt Specht presented the status of funds to the mayor and council on the city receiving a Community Development Block Grant (\$300,000).

PROGRAM SUMMARY

The City of Miles applied for and was awarded a \$300,000 Community Development Block Grant (CDBG) funds to provide funding to contribute to the construction of a three-celled controlled discharge lagoon system for wastewater.

Accomplishments To Date:

Cells have been constructed, waiting for the linear company to give an installation date. Will need to finish up some interior piping once the linear is in place. Pump station is in will have a little bit to complete. Project is moving along nicely and projected to be completed mid June.

Clerk's Report

City Clerk, Brenda Tebbe informed the council the city has received the "Paint Iowa Beautiful Award" which entitles the city was awarded 7 gallons of paint to either paint the front of city hall or the bathrooms at the park.

City Clerk, Brenda Tebbe informed the council the city has received the Derelict Building Grant. The funds awarded will go towards the deconstruction of 346 Ferry Road.

NEW BUSINESS

Council member N. Corlis made a motion to approve Res. 2023-05, A resolution adopting the annual budget for the fiscal year ending June 30, 2024, council member M. Leamy seconded the motion. Motion carried by roll call: N. Corlis ayes, M. Leamy aye, R. Lawrence aye, N. Abernathy aye, and D. Chrest aye.

Council member N. Abernathy made a motion to approve Res. 2023-08, A resolution appointing (Nancy Corlis) Commissioners to the Eastern Iowa Regional Housing Authority for the City of Miles, Iowa, seconded by council member R. Lawrence. Motion carried by roll: N. Abernathy aye, R. Lawrence aye, M. Leamy, aye, N. Corlis-abstain, and D. Chrest aye.

Council member M. Leamy made a motion to approve Payment #12 to Connolly Construction for the Wastewater Facility Project in the amount of \$319,754.53, seconded by council member D. Chrest. This payment will be made from the WTFAP grant (\$500,000) the city was awarded from the lowa Finance Authority Wastewater & Drinking Water Treatment Financial Assistance Program. Motion carried. Ayes 5, Nays 0.

Council member N. Corlis made a motion to accept the resignation with regret of City Attorney, Steven Kahler, it was seconded by council member M. Leamy. Motion carried. Ayes 5, Nays 0.

Within the resignation letter of Steven Kahler, he recommended Sara Davenport would be interested in being appointed as the City of Miles attorney. After a brief discussion on suggested attorney's, council member N. Abernathy made a motion to appoint Sara Davenport as Miles City Attorney, council member R. Lawrence seconded the motion. Motion carried. Ayes 5, Nays 0.

After Chief Deputy, Jim Kraker presented his proposal. Council agreed to contact sheriff's department and discuss what options the city has for police protection. Council directed City Clerk, Brenda to set up a meeting.

Bob & Carol Frahm approached the city hall to see if the city would pave approx. 150' of city property to extend into the street. Bob & Carol informed us that 7 Hills Paving will be asphalting there lane. Mayor and council would like the city clerk to contact Bob & Carol and see what the cost would be to do that 150'. This will be addressed at the next council meeting.

With recommendations from the city attorney and Blue Line Solutions some of the verbiage of the current ordinance on the Automated Traffic Enforcement needed to be re-vised. City Clerk, Brenda presented the new ATE revised Ordinance to the mayor and council. With a brief discussion, council member N. Corlis made a motion to approve the 1st Reading of Ordinance 2032-2, An Ordinance Amending Title II Policy and Administration Chapter 8 of the Miles Municipal Code Automated Traffic Enforcement and the means for challenging an Automated Traffic Citation, council member M. Leamy seconded the motion. Motion carried. Ayes 5, Nays 0.

ADJOURNMENT - Council member M. Leamy made a motion to adjourn the meeting, council member N. Corlis seconded the motion. Meeting adjourned at 6:44 p.m.
