Miles Regular Council Meeting Miles City Hall September 7, 2022 @ 6:00 p.m.

Miles City Council met in regular session on September 7, 2022 at 6:00 p.m. at Miles City Hall. PRESENT: Deb Chrest, R. Lawrence, N. Corlis, and M. Leamy. Mayor Danny Ernst presided.

APPROVAL OF AGENDA – Council member N. Corlis made a motion to approve the agenda as presented, it was seconded by council member D. Chrest. Motion carried. Ayes 4, Nays 0.

CITIZEN/PUBLIC COMMENTS - Tony Amsler gave a short introduction informing the mayor and council he is running for Iowa House of Representative in the NEW House District 66. He's married and a father of 2. Tony is visiting everyone in Jackson and Jones counties to talk to them about their concerns and ideas. CONSENT AGENDA - Council member M. Leamy made a motion to approve the consent agenda, including the minutes of previous meeting, paid, unpaid, financial statements, sewer, water, and maintenance reports, council member N. Corlis seconded the motion. Motion carried. Ayes 4, Nays 0.

CITIZEN/PUBLIC COMMENTS - Brett Stalker approached the council requesting to block off the street in front of his establishment (from 4:00 p.m. to midnight) for the Warrior Ride that he's hosting Saturday, September 10. Brett informed the council he has called the county and they approved his request, but they told him he would need to contact the city. Officer Miller stated to make sure there are signs posted for the oncoming traffic. Brett informed the council he would have everything cleaned up after midnight.

PUBLIC HEARING: PROPOSED WATER, SEWER, AND GARBAGE RATES

Mayor Ernst opened the public hearing at 6:10 p.m. (motion by council member D. Chrest, seconded by council member R. Lawrence) to solicit comments for the proposal to amend water, sewer, and garbage rates of the City of Miles. The primary purpose of the public hearing is for citizens to voice their objections or concerns. City Clerk, Brenda Tebbe informed the mayor and council she had a visit from concerned citizen. He wanted to know if the city would work with him if he struggled paying his bill. Brenda informed him we would but the city is going to enter into an agreement that the citizens can apply for water assistance to help with their bill. I told him this would be an option for him. Mayor Danny Ernst closed the public hearing at 6:12 p.m. with no negative comments from citizens present and no objections on file.

Motion by M. Leamy and seconded by council member R. Lawrence to close the Public Hearing for the proposal to amend water, sewer, and garbage rates at 6:12 p.m. No written oppositions were presented. Motion carried. Ayes 4, Nays 0.

MAINTENANCE REPORT - Paul Maze informed the council he was notified from a resident they had sewer backup in their basement. After doing some checking, Paul found that it has become a city problem with tree roots clogging a manhole. Paul contacted a company and has flushed out the manhole as well as digging out the tree roots. This has been forward onto the city insurance to see if they will cover the damages.

NEW BUSINESS

Council member M. Leamy made a motion to appoint a council person for the vacancy, instead of having a special election, it was seconded by council member N. Corlis. Motion carried. Ayes 4, Nays 0.

Council member N. Corlis made a motion to waive the 2nd & 3rd Reading and place on final adoption of Ordinance 2022-3 amending Water, Sewer, and Garbage rates, council member M. Leamy seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to approve Ordinance 2022-3, An Ordinance Amending Water, Sewer, & Garbage rates for the final reading and adopt Ordinance 2022-3, council member R. Lawrence seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to waive 2nd & 3rd Reading and place on final adoption of Ordinance 2022-4, An Ordinance by adding a new section (Golf Carts) to Title III Community Protection, Chapter 5 of the Miles Municipal Code, council member D. Chrest seconded the motion. Motion carried. Ayes 4, Nays 0.

A motion was made by council member M. Leamy to approve Ordinance 2022-4, for final reading and adopt Ordinance 2022-4 by adding a new section (Golf carts) to Title III Community Protection, Chapter 5 of the Miles Municipal Code, it was seconded by council member N. Corlis. Motion carried. Ayes 4, Nays 0.

A motion was made by council member R. Lawrence to waive 2nd & 3rd Reading and place on final adoption of Ordinance 2022-5, An Ordinance by adding a new section (Fireworks) to Title III Community Protection, Chapter 4 of the Miles Municipal Code, it was seconded by council member M. Leamy. Motion carried. Ayes 4, Nays 0.

Council member D. Chrest made a motion to approve Ordinance 2022-5 for the final reading and adoption Ordinance 2022-5, An Ordinance by adding a new section (Fireworks) to Title III Community Protection, Chapter 4 of the Miles Municipal Code, council member R. Lawrence seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to approve Res. 2022-22, A Resolution approving Iowa Department of Transportation (IDOT) 2021-2022 Street Finance and Authorizing the Mayor and City Clerk to sign, council member D. Chrest seconded the motion. Motion carried. Ayes 4, Nays 0.

Mayor Ernst informed the council the last ordinance the city passed on the Automated Traffic Enforcement did not support Blue Line Solution criteria. The speed limit verses the charges didn't generate enough money to support the cost of trailer coming to Miles. After some discussion the council member M. Leamy made a motion to amend the Automated Traffic Enforcement Ordinance to meet Blue Line Solution requirements, council member N. Corlis seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to approve Res. 2022-23, A Resolution approving the Disaster Recovery Plan for Financial Continuity, it was seconded by council member D. Chrest. Motion carried. Ayes 4, Nays 0.

Council member N. Corlis made a motion to approve Res. 2022-24, A Resolution approving the Urban Renewal Report for the Fiscal Year ending 2021-2022, council member R. Lawrence seconded the motion. Motion carried. Ayes 4, Nays 0.

At the last council meeting Barb Bulier suggested eliminating to burn in Miles for health reason of some residents. After council discussed with Officer Miller on calls pertaining to burning. The council agreed to leave the burning ordinance as is.

Council member N. Corlis made a motion to approve Payment No. 6 to Connolly Construction in the amount of \$224,600.00, council member M. Leamy seconded the motion. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to approve Change Order No. 2 at no cost to modify alignment and profile main generally from existing WWTF site to NE of Ferry Road intersection to avoid previously unmarked utilities and simplify alignment to reissue drawings, council member R. Lawrence seconded the motion. Motion carried. Ayes 4, Nays 0.

Eldon Schneider, Design Engineer of Origin Designs approached the council on the results of the soil sample that was taken at the new lagoon. The results came back needing an extreme amount of Bentonite. Meaning before they continue, they will need to research other options to avoid filling the ponds with exposure of Bentonite. The previous soil samples came back normal but since they've move dirt, they had to test the soil again. The cost to add the amount

of bentonite will be extremely costly. Eldon suggested installing a syntenic liner in the 3 ponds would be less expensive. Eldon will keep us updated on the additional cost.

Up for discussion is an email the mayor and council received from a resident addressing his concerns on his neighbor having a dog that isn't trained for the child that lives in that home. Officer Miller informed the council he has investigated all avenues of the situation and came up with not enough evidence to issue a ticket. Council was satisfied with the outcome of the officer results.

Council member N. Corlis made a motion to approve the Class "B" Beer permit with Sunday Sales for Jesse's Automotive & Mini Mart, council member R. Lawrence. Motion carried. Ayes 4, Nays 0.

Council member M. Leamy made a motion to enter into an agreement with Iowa Low-Income Household Water Assistance Program (LIHWAP), council member N. Corlis seconded the motion. This program will assist resident in their water bill if they met the requirements. Motion carried. Ayes 4, Nays 0.
